#### **Business Conducted:**

- **2. Warrant:** George motioned to approve Warrant No. 4 for a total of \$101,477.64 (Payroll-\$2,012.21; Accounts Payable-\$99,465.43); Jerry, 2<sup>nd</sup>; vote: 3-0.
- **3. Board of Selectmen Minutes:** George motioned to accept the minutes of July 13, 2015; Ross, 2<sup>nd</sup>; vote: 3-0
- 4. Spirit of America Award: Tabled.
- **5. Tim Forrester's Report on the Amistadi Property:** The Amistadi Property is within the 80% survival rate of trees planted.
- **6. CAI Technology:** CAI Technology has informed the town that if any landowner wants their name masked from the Town website property list, the landowner can call the 3<sup>rd</sup> Selectman Ross Norton at 882-6242.
- **7. Baker Road Issue:** Jerry motioned to have the Baker Road issue turned over to the Town Attorney; George, 2<sup>nd</sup>; vote: 3-0.
- **8.** Letter to Leslie Lilly: George motioned to send a certified letter to Leslie Lilly to remove the boulders from the Town's right of way; Jerry, 2<sup>nd</sup>; vote: 3-0.
- **9. Flood Insurance Rate Map (FIRM) Letter of Map Change (LOMC) revalidation:** FEMA notified the Town of a change to the Flood Insurance Rate Map validating removal of the following parcels from the 100-year flood plain, A.K.A. the Special Flood Hazard Area (SFHA), putting them in the "X" zone: Map #3, Lot 20; and Map #1, Lot 60.

- **10. MDOT Local Road Assistance Program (LRAP):** MDOT Capital Improvement LRAP form has been filled out for: Willis Point Road, Fowles Point Road, and West Shore Road. George motioned to approve the LRAP form; Jerry, 2<sup>nd</sup>; vote: 3-0.
- **11. Fire Department Grant Application:** The Westport Volunteer Fire Department has filled out a grant application for SCBA (Self Contained Breathing Apparatus) gear for \$3,016.00. George motioned to approve the Fire Chief's application; Jerry, 2<sup>nd</sup>; vote: 3-0.
