Business Conducted:

- **2. Warrant:** George motioned to approve Warrant No. 15 for a total of \$7,904.40 (Payroll-\$844.00; Accounts Payable-\$7,060.40); Jerry, 2nd; vote: 3-0.
- **3. Board of Selectmen Minutes:** George motioned to accept the minutes of September 28, 2015; Jerry, 2nd; vote: 3-0.
