**March 19, 2018**

**Meeting Convened:** George called the meeting to order at 07:10 p.m.

**Business Conducted:**

**1. Warrant:** George motioned to approve Warrant Nos. 78 & 79 for a total of \$ 57,253.59. (Payroll No. 78 - \$1,183.32; Accounts Payable No. 79 - \$ 56,070.27); Jerry, 2nd; vote: 3-0.

**2. Board of Selectmen Minutes:** George motioned to accept and sign the minutes of March 12, 2018; Jerry, 2nd; vote: 3-0.

**3. Citizens Issues:** Jeff Tarbox discussed the possibility of creating a 501(c)3 Friends of the History Committee non-profit to run alongside the Town History Committee. George advised him that to do this, he would need to create a warrant article for this year's Annual Town meeting.

**4. Pier, Ramp and Float Hearing for Map 005, Lot 04.01:** George presented the Board of Selectmen and the Press present, a copy of the Westport Island Public Notice concerning a license to Kennebec Marine Service to construct and install a permanent pier/seasonal ramp and float ramp into the Montsweag Bay on Map 005, Lot 04.01.

**5. Request for Tree Growth:** Resident Scott Bowman applied for tree growth on three lots that were under Tree Growth when previously owned by Thomas Jacoby. The Board of Selectmen agreed to return the applications to Scott Bowman for corrections needed.

**6. Donation for History Committee:** George showed everyone present the 1950 Causeway Dedication booklet that long-time resident Marjorie Cromwell/Baily/Pooler was donating to the History Committee. George plans to present it on her behalf at tomorrow evening's History Committee meeting.

**7. L. Lilly Baker Road Court Case Rehearing:** George advised that Lawyer Bill Dale said that Judge Billings had agreed to a rehearing of facts on the L. Lilly Baker Road Case on April 3, 2018 at 01:30 pm.
