**Meeting Convened:** George called the meeting to order at 7:05 pm.

**Business Conducted:**

**1. Warrant:** George motioned to approve Warrant Nos. 99 & 100 for a total of \$12,825.55 (Payroll No.99 - \$2,752.02; Accounts Payable No.100 - \$10,073.53); Ross, 2<sup>nd</sup>; vote: 3-0.

**2. Minutes:** George motioned to accept the minutes of May 20, 2019 minutes; Ross, 2<sup>nd</sup>; vote: 3-0.

**3. Wright Landing Food Pantry State Inspection Compliance:** George motioned that Selectman Ross Norton purchase a second 5 lb. fire extinguisher for \$53.99 at Ames Supply for use in the Food Pantry; Jerry, 2<sup>nd</sup>; vote: 3-0.

**4. Ralph & Joanna Jacobs North End Road Issue:** George motioned to table discussion until after town meeting; Ross, 2<sup>nd</sup>; vote: 3-0.

**5. Table & Chair Usage Request:** George received a request for tables and chairs from town hall for use at wedding of Jackson Cromwell/Elise Hartill. George motioned to approve the usage of the folding chairs and a few tables for a small donation; Jerry, 2<sup>nd</sup>; vote: 3-0.

**6. Mary Stacey Funeral/Wake:** George motioned to waive the Town Hall fee for the funeral/wake of Mary Stacey; Jerry, 2<sup>nd</sup>; vote: 3-0.

**7. Fire Department Cook-Out:** A cook-out for the benefit of the fire department is being handled by Mario DePietro and committee on July 14, 2019.

**8. William H. Brewer Audit:** George motioned to approve the signing of the audit from William H. Brewer; Ross, 2<sup>nd</sup>; vote: 3-0.

**9. Parking for Holly Stover's Daughter's Wedding:** George motioned to approve Holly Stover's request to use the Town Hall and Town Office parking lots for excess parking at her daughter's wedding happening at the Squire Tarbox Inn on June 8, 2019; Jerry, 2<sup>nd</sup>; vote: 3-0.

**10. Dog Complaints:** Jeff Stone has 2 dogs that have been running at large with no supervision. We have received numerous citizen complaints and he has been warned several times by Animal Control for safety reasons. Tracy Clark has 3 dogs and we have been trying to get her to come in for licensure since the beginning of the year. Over the past few years, we have has numerous complaints regarding these dogs and need to make sure that they are licensed and have their shots.
