- **5. Staff Requests:** George motioned to table the request for the office to be closed on December 26th for Christmas and to approve the "Annual" Ring in The New Year Party for February. Jerry, 2nd; vote: 3-0.
- 6. Surveillance Camera for Use in The Sand and Salt Shed: The Selectmen had requested at the November 4, 2019 meeting to price out cameras for the Sand & Salt Shed to monitor usage.
