Business Conducted:

1. Warrant: George motioned to approve Warrant Nos. 50 & 51 for a total of \$2,512.45 (Payroll No. 50 - \$1,348.06; Accounts Payable No.51 - \$1,164.39); Jerry, 2nd; vote: 3-0.

2. Minutes: George motioned to accept the minutes of December 10, 2018; Ross, 2nd; vote: 3-0.

3. Comprehensive Planning Committee: Ted Christie will replace Frank "Bud" Gallagher on the Comprehensive Planning Committee.

4. Federal Emergency Management Agency (FEMA) Meeting: FEMA to meet with Roger Higgins and Gaye Wagner on December 18, 2018 to discuss closure of the storm of October 30, 2017. George thanked Roger and Gaye and all involved for their efforts with this devastating storm.

5. Westport Island Records Preservation: George motioned to approve the purchase of an external hard drive for the Town's records preservation purposes. Up to \$100.00 was requested and authorized for the purchase of a hard drive. Ross, 2^{nd} ; vote: 3-0.
