- **6.** Baker Road Update: Donna shared that the Consent Agreement was signed.
- **7. Roads:** Jim Cromwell reported that Jack Shaw has been spreading gravel on the worst spots on dirt roads. Driveways have been beveled on Greenleaf and East Shore Roads, with shouldering happening soon. Crooker has finished paving those roads and came in \$745.00 under the estimate. The DOT started paving Main Rd. this morning. Jim has added two 35 mph signs on the paved section of East Shore Rd.
- **8.** Correspondence: Lisa reported that the Select Board received a request from the Lincoln County Regional Planning Commission asking them to write a letter of support for a grant for federal housing-related technical assistance to Lincoln County towns including assistance for re-writing ordinances; Lisa motioned to write a letter of support; Donna 2nd; Vote 3-0

- Donna reported that the State Legislature has repealed the senior tax stabilization program. Anyone who applied and was approved will still receive the freeze on their 2023 tax bill. There will be no re-application process. There are two other tax relief programs that people can still apply for, and the town will share information about those.

- Donna reported that they have not heard back from the Longobardis and will follow up with their attorney.
- Jim requested that thank you notes be sent to the people who allowed the road crews to park vehicles on their property during the recent road improvements. April will work on that.
