Business Conducted:

1. Warrant:

- Donna motioned to approve the Payroll Warrant #110 for \$1,916.42; Lisa 2nd;
 vote: 3-0

3. Citizen's Issues

- Camden Reiss from Protect Maine's Fishing Heritage Foundation spoke about his
 efforts to educate towns about the increase in large scale aquaculture and its
 effects on the local fisheries and folks who fish locally. He presented a suggested
 draft ordinance adopted by towns to protect their local waters.
- Mary Ellen Barnes from the Westport Island History Committee asked for permissions to sell raffle tickets for a handmade quilt at this year's Town Meeting. The board did not see any problem with this other than making sure it doesn't take space away from the seating area for citizens.

4. Roads:

Donna moved to accept the statewide salt bid of \$80/ton with a purchase of 120 tons. We reserve the right to purchase 1/3 less or up to 1/3 more if needed at this price. Jeff 2nd; vote: 3-0
